




CMMC Compliance Success - Vibrint's Microsoft Government Cloud Migration

The environment was complex due to an acquisition that resided in a Commercial M365 tenant and their antiquated on-prem email platform. With an aggressive timeline, Daymark migrated Microsoft

GCC High and on-premises workloads to the Azure Government cloud as well as Azure Virtual Desktop infrastructure for enclave user access to sensitive data. The strategy ensured CMMC and ITAR compliance, streamlined operations and provided robust security and efficiency to protect sensitive data.

Customer challenges



With a recent merger and urgent deadline, they required a solution to support the entire company and provide access for new employees on day one. Daymark Solutions met the customer's aggressive timelines and orchestrated secure migration and adoption in preparation for a future CMMC 2.13 L2 assessment.



Daymark Solutions migrated the client directly into GCC High using native Microsoft hybrid email migration methodology and 3rd party tenant-to-tenant migration tools. Using Microsoft Purview, Daymark enhanced compliance control tracking and regulatory functionality within Microsoft 365 and Azure Government Cloud. Azure Virtual Desktop was deployed to meet immediate day-one employee access requirements, secure data and applications, and manage M365 access.
